A SCHEME FOR PRELIMINARY COMPETITIONS FOR YOUTHS & SCHOOL CHILDREN TO MAJOR TOURNAMENTS has been accepted in principle by the Council. The idea is to provide more competition and an incentive to young fencers to participate in major events. A low entry fee will be charged and a certain number will earn the right to free entry to the main event.
